# NALSC Providing Legal Aid assistance

### **Our Clients**

NALSC Legal Aid helps low-income persons, with certain legal matters. NALSC Legal Aid have the authority to issue Legal Aid certificates to qualifying Community members from the Nishnawbe- Aski Nation (NAN) First Nations communities, in Northern Ontario

### Do you qualify for Legal Aid Certificate?

NALSC Legal Aid Program (NALSC) can issue Legal aid certificates to members of NAN Communities, who are financially eligible, and the legal matter must be covered by Legal Aid Ontario (LAO).

NALSC Legal Aid abides by the LAO guidelines in determining the financial eligibility of a person applying for legal aid. If you are eligible and face a serious legal matter, you can apply for a free Legal Aid Certificate.

Depending on your income, you may need to make monthly payments towards the cost of some or all of your legal fees. You will need to take a financial test to see if your gross income, from all sources, is within the range of the Financial Charts below.

### What if I do not qualify for a lawyer?

We may be able to help you either over the phone or if you are in court and need help immediately. Check the Financial Charts to see if you qualify.

# Legal Matters that are covered

Our Legal Aid Program can assist with legal matters on:

- Criminal Law (if custody is probable)
- Family Law
- Child Welfare
- some administrative law issues

NALSC Legal Aid cannot assist with legal matters related to: civil law, employment law, human rights, housing or social assistance.

# NALSC Duty Counsel

NALSC Legal Aid provides Duty Counsel, on the day before court, called "Advance Day," and on the day of Court Day, to assist people who appear in Court without a lawyer.

Duty Counsel assists people:

- in NAN Communities by providing *summary legal advice* on a variety of issues
- Provides *summary legal advice* without fees
- assist with legal & government forms

NALSC Staff Lawyer(s) provides brief service or short summary legal advice to qualifying NAN community members. It applies only to questions for qualifying legal issues.

# **COMMUNITY LEGAL WORKERS:**

- Provide legal information and referrals to members of NAN communities.
- Liaise with justice personnel and First Nation leadership on court and justice issues.
- Complete legal aid applications with clients and help them find lawyers.
- Help clients navigate legal processes.
- Attend advance and list court days in NAN communities.
- Assist clients in completing routine forms.
- Make referrals to NALSC Programs.

### Courts

- Community Legal Workers (CLWs) attend court on advance and list days in each of the communities they serve.
- CLWs may also attend court in northern urban centres if there are NAN members requiring assistance.
- Duty counsel is available on advance and list days for community members with matters before the court.
- Duty counsel offers free summary legal advice to all community members on advance days without an appointment.





I also assist clients with Firearms Application, Commissioning delayed statement of birth forms, or assisting with any other documentation they require. As a Commissioner of Oaths, we are also limited to what we can Commission. We, CLW's, also cover each other's communities when a CLW is not able to be there. As a CLW, we are expected to do our community visits and to be visible within each of our communities. I enjoy my work as a Community Legal Worker and enjoy meeting new people, enjoy working with my colleagues, and enjoy working with all the justice personelle that we have come to know over the years.

I had the pleasure to work with NAN elders in developing NALSC's Vision Statement


VISION: To respect and revitalize Restorative Justice forms of justice through Indigenous laws and Pimatisiwin (way of life)"

I am Ashley Richards, I am a member of Ginoogaming First Nation and I'm the Communications Coordinator here at NAN Legal.



# Looking for Alternatives to Court for Family Matters?

What is the difference between Mediation and Collaborative Family Law?

### MEDIATION

- A voluntary process where two parties come to a fair agreement
- Less expensive than court process (and there are funding programs available)
- Conducted by a Social Worker, Psychologist, or Lawyer
- They do not tell you how resolve issues they make suggestions
- They screen both parties to ensure they are good candidates for the process
- Can be done together at a table or in separate rooms
- If you agree with the outcome, take it home and consider it before signing
- If you don't agree: try again or go to court

COLLABORATIVE FAMILY LAW

- More expensive than Mediation
- Faster and cheaper than the court process but your interests are still protected by a lawyer
- Focused and directed by you for your family
- Four way meetings between each spouse and their lawyers to create a solution that meets your family's unique needs and legal requirements
- You are not able to work with theses lawyers if you use the court process

NOTE: WHERE THERE IS A HISTORY OF ABUSIVE OR CONTROLLING BEHAVOUR, THESE ALTERNATIVE PATHWAYS ARE LESS LIKELY TO WORK. IF YOU ARE UNSURE, TALK TO A PROFESSIONAL ABOUT YOUR CIRCUMSTANCES.
