- Keep the community members of NAN informed of new developments & changes in law and policy.
- Engage in Preventive Law by delivering PLE Activities.
- Provide Legal information in plain language and in a format that is easy-to-understand.
- Ensure community members of NAN are aware of the Programs and Services offered by NALSC.
